Massimo Paolucci,

Member of the European Parliament (MEP)



Born 58 years ago in a working-class neighbourhood of Naples. The experience of political militancy began very early, in the '70s with the PCI (Italian Communist Party). Fishing Operations and Technology Branch, Food and Agriculture Organization of the United Nations



Joanna Toole has an academic background in animal behaviour and wildlife biology but has become increasingly specialised in marine conservation issues throughout her career. Joanna currently works in the Fishing Operations and Technology Branch of the Food and Agriculture Organization of the United Nations (FAO) where her key focus is advancing FAO's work on abandoned, lost or otherwise discarded fishing gear (ALDFG). Joanna manages a number of projects which FAO have implemented to address the contribution of fisheries to the marine debris issue and over the last two years Joanna has been involved in the development of FAO's recently adopted Voluntary Guidelines for the Marking of Fishing Gear which are considered to be an important tool in efforts to prevent ALDFG. Joanna represents FAO on the Steering Committee of the Global Partnership for Marine Litter (GPML) and is currently co-chairing this Committee. Joanna has an NGO background and in previous roles led the formation of the Global Ghost Gear Initiative (GGGI), a cross-sectoral alliance dedicated to addressing the global problem of ALDFG and has also worked on microplastic and macroplastic issues for other NGOs.

Christine Haffner-Sifakis works on UN Environment's Partnerships, Programmes & Policies with the European Commission other key stakeholders with a particular focus on bridging the programmatic and policy dimensions from the UN Environment Brussels Office. Prior to that she was coordinating UN Environment's **GEF** portfolio transboundary international waters projects in Africa and has been strongly involved in supporting Regional ocean governance.
